

BID NOTICE UNDER OPEN DOMESTIC BIDDING

INVITATION TO BID FOR SUPPLY AND INSTALLATION OF OFFICE FURNITURE AND FITTINGS FOR THE WORKSPACE AT UDB TOWER-PROCUREMENT REFERENCE NUMBER: UDB/SUPLS/2024/00028

- 1. Uganda Development Bank Limited has allocated funds to be used for the Supply and Installation of Office Furniture and Fittings for the Workspace at UDB Tower.
- 2. The Entity invites sealed bids from eligible bidders to provide the above supplies.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003 (Amended), the PPDA (Procurement of Supplies) Regulations, 2023 and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below in clause 8 (Local time) during working days (Monday Friday).
- 5. Interested bidders may purchase the Bidding documents in English by submitting a written application to the address below in clause 8 and upon payment of a non-refundable fee of UGX 100,000 (Uganda Shillings One Hundred Thousand Only). The method of payment shall be by electronic transfer or cash. Payments should be made at Name of Bank: DFCU Bank, Account Number: 01013500015673, Account Name: Uganda Development Bank Limited. Payment shall be made in the legal name of the bidder interested in submitting a bid for the supplies required.
- 6. Bids must be delivered to the address below in clause 8 at or before 11:00 am on 25th October 2024. All bids must be accompanied by a bid security for each lot, as detailed below. Bid securities must be valid until 28th February 2025. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below in clause 8 at 11:30 am on 25th October 2024;

Lot 1, 2, 3 = UGX 2,000,000 (Uganda Shillings Two Million Only) for each Lot.

Lot 4, 5, 9 = UGX 1,000,000 (Uganda Shillings One Million Only) for each Lot.

Lot 6,7,8 = UGX 200,000 (Uganda Shilling Two Hundred Thousand Only) for each Lot.
